- iii. David Toyn shall only provide legal services in connection with the provision of litigation or any claims work as an employee and only where the employment has first been approved by the SRA.



David Toyn shall not supervise others providing legal services in connection with the provision of litigation or any claims work.

The above conditions are made under rule 3.2 of the SRA Regulatory and Disciplinary Procedure Rules, which states that at any stage an authorised decision maker may, pending a final decision by the SRA or the Solicitors Disciplinary Tribunal, impose interim conditions on the practising certificate of a solicitor.
