## Introduction

These rules govern the way that we operate the SRA Compensation Fund. This is a discretionary fund of last resort for making grants to people whose money has been stolen, or has not been accounted for, as a result of the acts or omissions of those regulated by us, and to relieve losses for which firms authorised by us should have had, but did not have, insurance.

It is funded by contributions from individuals and firms authorised by us.

We have provided guidance on the way we operate the fund.

The [Fund](https://indemnity.sra.org.uk/solicitors/standards-regulations/glossary/#Fund) [\[https://indemnity.sra.org.uk/solicitors/standards-regulations/glossary/#Fund\]](https://indemnity.sra.org.uk/solicitors/standards-regulations/glossary/#Fund) is a discretionary fund of last resort and no [person](https://indemnity.sra.org.uk/solicitors/standards-regulations/glossary/#person) [\[https://indemnity.sra.org.uk/solicitors/standards-regulations/glossary/#person\]](https://indemnity.sra.org.uk/solicitors/standards-regulations/glossary/#person) has a right to a grant enforceable at law.

For any grant to be made out of the [Fund](#) [\[https://indemnity.sra.org.uk/solicitors/standards-regulations/glossary/#Fund\]](https://indemnity.sra.org.uk/solicitors/standards-regulations/glossary/#Fund), an [applicant](#) [\[https://indemnity.sra.org.uk/solicitors/standards-regulations/glossary/#applicant\]](https://indemnity.sra.org.uk/solicitors/standards-regulations/glossary/#applicant) must satisfy the [SRA](#) [\[https://indemnity.sra.org.uk/solicitors/standards-regulations/glossary/#SRA\]](https://indemnity.sra.org.uk/solicitors/standards-regulations/glossary/#SRA) that the [applicant](#) [\[https://indemnity.sra.org.uk/solicitors/standards-regulations/glossary/#applicant\]](https://indemnity.sra.org.uk/solicitors/standards-regulations/glossary/#applicant) is eligible in accordance with rule 4 and (save in respect of a grant made under rule 3.4) has suffered or is likely to suffer:

  1. an individual whose dealings have been in a personal capacity with the [defaulting practitioner](https://indemnity.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner) [\[https://indemnity.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner\]](https://indemnity.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner) and who has suffered or is likely to suffer loss due to a failure to account shall be deemed to have suffered hardship; and

4. A [person](https://indemnity.sra.org.uk/solicitors/standards-regulations/glossary/#person) [https://indemnity.sra.org.uk/solicitors/standards-regulations/glossary/#person] is eligible under this rule to apply for a grant out of the [Fund](https://indemnity.sra.org.uk/solicitors/standards-regulations/glossary/#Fund) [https://indemnity.sra.org.uk/solicitors/standards-regulations/glossary/#Fund] where the [person](https://indemnity.sra.org.uk/solicitors/standards-regulations/glossary/#person) [https://indemnity.sra.org.uk/solicitors/standards-regulations/glossary/#person]:
1. is an individual; or
  2. at the time the application is made, is a sole trader, [partnership](https://indemnity.sra.org.uk/solicitors/standards-regulations/glossary/#partnership) [https://indemnity.sra.org.uk/solicitors/standards-regulations/glossary/#partnership], body corporate, unincorporated association or mutual association with an annual [turnover](https://indemnity.sra.org.uk/solicitors/standards-regulations/glossary/#turnover) [https://indemnity.sra.org.uk/solicitors/standards-regulations/glossary/#turnover] of less than £2 million, and does not fall within rule 4.2, 4.3(a) or 4.4(a).
5. A [person](https://indemnity.sra.org.uk/solicitors/standards-regulations/glossary/#person) [https://indemnity.sra.org.uk/solicitors/standards-regulations/glossary/#person] is eligible under this rule to apply for a grant in the circumstances set out in rule 3.1(a) if at the time the application is made the [person](https://indemnity.sra.org.uk/solicitors/standards-regulations/glossary/#person) [https://indemnity.sra.org.uk/solicitors/standards-regulations/glossary/#person] falls within one or more of the following categories:
1. a [charity](https://indemnity.sra.org.uk/solicitors/standards-regulations/glossary/#charity) [https://indemnity.sra.org.uk/solicitors/standards-regulations/glossary/#charity] with annual income net of tax in the most recent financial year of less than £2 million; or
  2. a [trustee](https://indemnity.sra.org.uk/solicitors/standards-regulations/glossary/#trustee) [https://indemnity.sra.org.uk/solicitors/standards-regulations/glossary/#trustee] of a trust with an asset value of less than £2 million.
4. 1. at the time the application is made falls within one or more of the following categories:
    1. a [charity](https://indemnity.sra.org.uk/solicitors/standards-regulations/glossary/#charity) [https://indemnity.sra.org.uk/solicitors/standards-regulations/glossary/#charity] with annual income net of tax in the most recent financial year of less than £2 million; or
    2. a [trustee](https://indemnity.sra.org.uk/solicitors/standards-regulations/glossary/#trustee) [https://indemnity.sra.org.uk/solicitors/standards-regulations/glossary/#trustee] of a trust with an asset value of less than £2 million; and
  2. has satisfied the [SRA](https://indemnity.sra.org.uk/solicitors/standards-regulations/glossary/#SRA) [https://indemnity.sra.org.uk/solicitors/standards-regulations/glossary/#SRA] that its beneficiaries have suffered, or



are likely to suffer, hardship if a grant is not made.

4.   4. are for interest payable to the [applicant](https://indemnity.sra.org.uk/solicitors/standards-regulations/glossary/#applicant) [https://indemnity.sra.org.uk/solicitors/standards-regulations/glossary/#applicant], save where the discretion to make a grant under rule 8 is exercised;
  5. are suffered by the Legal Aid Agency as a result of making regular payments under the Agency's contracting schemes for civil or criminal work;
  6. are where the [applicant](https://indemnity.sra.org.uk/solicitors/standards-regulations/glossary/#applicant) [https://indemnity.sra.org.uk/solicitors/standards-regulations/glossary/#applicant]:
    1. has been made bankrupt and any grant would vest in the trustee in bankruptcy;
    2. has entered into a voluntary arrangement with their creditors and any grant would vest in the administrator of



- the arrangement; or  
3. is in liquidation.

18. Where the [SRA \[https://indemnity.sra.org.uk/solicitors/standards-regulations/glossary/#SRA\]](https://indemnity.sra.org.uk/solicitors/standards-regulations/glossary/#SRA) makes a grant otherwise than by way of loan or if by way of loan repayments of the loan is waived or otherwise the borrower has failed to repay part or all of the loan, the [SRA \[https://indemnity.sra.org.uk/solicitors/standards-regulations/glossary/#SRA\]](https://indemnity.sra.org.uk/solicitors/standards-regulations/glossary/#SRA) shall be subrogated to the rights and remedies of the [person \[https://indemnity.sra.org.uk/solicitors/standards-regulations/glossary/#person\]](https://indemnity.sra.org.uk/solicitors/standards-regulations/glossary/#person) to whom or on whose behalf the grant is made to the extent of the amount of the grant.

20. If the [SRA \[https://indemnity.sra.org.uk/solicitors/standards-regulations/glossary/#SRA\]](https://indemnity.sra.org.uk/solicitors/standards-regulations/glossary/#SRA) refuses to make a grant of either the whole or part of the amount applied for, the [applicant \[https://indemnity.sra.org.uk/solicitors/standards-regulations/glossary/#applicant\]](https://indemnity.sra.org.uk/solicitors/standards-regulations/glossary/#applicant) will be informed in writing of the reasons for the decision.
20. The fact that an application has been rejected does not prevent a further application being submitted provided that material new relevant evidence or information is produced in support of the new application.

Where a grant is made, the [SRA](https://indemnity.sra.org.uk/solicitors/standards-regulations/glossary/#SRA) [\[https://indemnity.sra.org.uk/solicitors/standards-regulations/glossary/#SRA\]](https://indemnity.sra.org.uk/solicitors/standards-regulations/glossary/#SRA) may consider an application for a further grant in respect of the reasonable costs properly incurred by the [applicant](https://indemnity.sra.org.uk/solicitors/standards-regulations/glossary/#applicant) [\[https://indemnity.sra.org.uk/solicitors/standards-regulations/glossary/#applicant\]](https://indemnity.sra.org.uk/solicitors/standards-regulations/glossary/#applicant) with either their solicitor or other professional adviser, provided that such costs were incurred wholly, necessarily and exclusively in connection with the preparation, submission and proof of the application.
