Introduction

The SRA, through the Law Society, is a designated professional body under Part 20 of FSMA. This means that firms (including sole practices) authorised by us may carry on certain regulated financial services activities without being regulated by the FCA if they can meet the conditions in section 327 of FSMA. The purpose of these rules is to set out the scope of the regulated financial services activities that may be undertaken by firms authorised by us and not regulated by the FCA.

These rules do not apply to solicitors, RELs, RFLs or RSLs practising outside firms authorised by us.

This introduction does not form part of the SRA Financial Services (Scope) Rules.

If you carry on any [regulated financial services activities](https://indemnity.sra.org.uk/solicitors/standards-regulations/glossary/#regulated-financial-services-activities) [\[https://indemnity.sra.org.uk/solicitors/standards-regulations/glossary/#regulated-financial-services-activities\]](https://indemnity.sra.org.uk/solicitors/standards-regulations/glossary/#regulated-financial-services-activities) you must ensure that:
 2. you satisfy the conditions in section 327(2) to (5) of [FSMA](https://indemnity.sra.org.uk/solicitors/standards-regulations/glossary/#FSMA) [\[https://indemnity.sra.org.uk/solicitors/standards-regulations/glossary/#FSMA\]](https://indemnity.sra.org.uk/solicitors/standards-regulations/glossary/#FSMA);

If you are a COLP or a nominated authorised signatory for a firm we regulate, you need to let us know whether or not your firm carries out financial activities for clients as part of your legal work.
