## **Outcome details**

This outcome was reached by SRA decision.

### **Reasons/basis**

This notification relates to a Decision to prosecute before the Solicitors Disciplinary Tribunal. This is an independent Tribunal which will reach its own decision after considering all the evidence, including any evidence put forward by the Solicitor. The Tribunal has certified that there is a case to answer in respect of allegations which are or include that:-

1. Between 1 January 2020 and 31 January 2024, Mr Azotam misappropriated client monies for the benefit of himself and his Firm creating a minimum client account shortage that has not been replaced.
2. On 6 March 2023 and 14 November 2023, Mr Azotam issued cheques to a client when he knew that the Firm did not have sufficient funds to honour either of them, thereby misleading the client.
3. Between 1 April 2020 and 8 March 2024, Mr Azotam failed to ensure the Firm's books of account were maintained in compliance with the SRA Accounts Rules.



The allegations are subject to a Hearing before the Solicitors Disciplinary Tribunal and are as yet unproven.
